HOTA

HOTA, Home of the Arts is a growing and ambitious arts precinct on the sun-filled Gold Coast with over 680,000 visitors every year.

The Team

The Gallery and Visual Arts team lead the development and management of HOTA Gallery, Australia's largest public art museum outside a capital city. They collaborate with all areas of Experience Gold Coast and HOTA, and are responsible for presenting visual arts exhibitions and programming for the artistic direction of HOTA within the Gallery and across the precinct. They are responsible for the development, research and care of the city collection of approximately 4,500 artworks including exhibitions, loans and digital access.

The Position

Reporting to the Director, Gallery and Visual Arts, the Curatorial and Engagement Manager leads the development and implementation of an exceptional program of visual arts exhibitions and

experiences throughout HOTA Gallery and the wider precinct; including narratives and content from the city collection, curated Australian and international exhibitions of art and design, and travelling exhibitions.

The position is responsible for managing the curatorial, public programs and education team, is a member of the HOTA senior managers group, and an interdisciplinary programming team that delivers art, entertainment, cultural and lifestyle experiences.

The position contributes to the development and implementation of visual arts policy and strategy across the precinct and provides input and oversight of the visual arts budget.

Position Responsibilities

Duties include, but are not limited to:

- Oversee, develop and curate imaginative and distinctive exhibitions and projects for display and tour, including working closely with artists, the city collection, and external sources in line with the vision and strategic outcomes of HOTA.
- Work collaboratively with the Exhibitions and Collections Manager, and exhibitions and collections team to ensure a high standard of display and presentation of the collection, exhibitions and projects.
- Provide leadership in the development and implementation of memorable learning and engagement experiences that support and enhance the exhibitions, visitor experience and wider creative program across the Precinct.
- Play a leading role and contribute to an innovative, integrated creative program; ensuring there is a balance between artistic and commercial considerations and that projects evenly cater for popular and niche audiences.
- Ensure that First Nations voices, principles and perspectives are embedded throughout HOTA's creative program.
- Support the Director in the strategic development and growth of the city collection in accordance with the Collection Management Plan and Acquisition Strategy.
- Assist in the preparation and management of exhibition, program and collection budgets. Provide advice on external funding opportunities for creative projects through appropriate grant platforms and sponsorships.
- Research and prepare imaginative and distinctive written material on the collection and exhibitions for display and publication. Develop exhibition briefs, acquisition proposals, and other associated publications.
- Supervise, develop and mentor the curatorial and program team, including professional development and regular feedback. Develop and model a culture of continuous improvement, including building commitment to shared goals.
- Represent HOTA at speaking engagements, external judging panels, committees and industry related forums and events as required.
- Effectively communicate with stakeholders including artists, donors, sponsors, EGC Board of Management, and by actively engaging with the local and national visual arts sector.
- Develop and nurture a strong and broad network of strategic relationships to benefit the Precinct's continued growth and development in the visual arts.
- Oversee and respond to inquiries from colleagues, artists, researchers and the general public.
- Always act ethically and with integrity.
- Model and promote positive and productive behaviours within the workplace.
- As directed by the Director, Gallery and Visual Arts, undertake other related duties within the scope of this position.
